It was successful, and the grant just came through. She had also never received her IRS stimulus checks or her most recent refund, and I was able to get that straightened out, as well.

Grant Updates

Second ARPA Grant

I've submitted the final report for this grant, so it's now complete.

ARSL New England Grant

I'm still waiting for Meg Hopkins to pick up the signs for the school. Two copies of the first Storywalk story (Oliver Jeffers' *Stuck*) are on their way, as well as the laminating film. It would be helpful to order Storywalk backer sheets, something I didn't realize until now. We can certainly tape the laminated pages to the black

metal backing, but it would be much easier to put the storywalk together inside, rather than outside. It's not a necessity, but would be nice to have at some point. The cost would be \$113.40, but we've exhausted the grant. The grant report is due in February, which gives me plenty of time to get some good photos and feedback from kids.
